- Vendor or its agents/employees using this facility related to the event agree to abide by all rules, regulations and recommendations of Camp Albrecht Acres and its Staff.
- Vendor or its agents/employees does/do hereby release and forever discharge and hold harmless Camp Albrecht Acres from all liability claims and demands which arise while on Albrecht Acres' grounds or any activity carried on by vendor does hereby release and forever discharge Camp Albrecht Acres from any claim whatsoever which arises on account of any first aid, treatment, or service rendered in connection with the Volunteers activities with Camp Albrecht Acres. Vendor or its agents/employees assume the risk of injury or harm in the activities and releases Camp Albrecht Acres from all liability for injury, illness, death or property damage resulting from the activities and does hereby release and forever discharge Camp Albrecht Acres from any claim whatsoever which arises on account of any first aid, treatment, or service rendered in connection with the activities.
